

### The role of the National Anti-Corruption Coordinator

The Minister of Justice, in the role of the National Anti-Corruption Coordinator, coordinates the work for the drafting of policies and the preparation of legal and by-laws for the prevention and fight against corruption.

The National Anti-Corruption Coordinator is responsible for verifying (administrative investigation) denunciations/complaints about abusive, corrupt or arbitrary practices for the implementation of law, as well as identifying employees of institutions, part of the Network of Coordinators, who, by actions or omissions, have committed violations of legal/sublegal acts in force, as well as simultaneously the development of projects and programs in the field of anti-corruption, planning, coordination and determination of necessary instruments for the implementation of policies in the field of anti-corruption.

The electronic newsletter is a broad communication tool that aims to inform by reflecting a summary of the main activities developed by the Ministry of Justice in the anti-corruption field, on a monthly basis.

#### Announcing the public consultation of the draft of Intersectoral Strategy Against Corruption, 2023 - 2030

Që nga miratimi i SNKK në vitin 2015, Shqipëria ka ulur nivelin e nivelit të korrupsionit dhe përgjigjësinë dhe kapacitetet shëndetësore për të parandaluar, detektuar dhe luftuar korrupsionin. Në numër të madh i lartë reformave janë bërë deri tashmë dhe kanë dhënë rezultate të kështu të shprehura të SNKK dhe shërbime të tilla të tjerat.

**15-26.08.2022:** The Ministry of Justice continues to work on drafting the Intersectoral Strategy Against Corruption 2023-2030. There were held dedicated meetings during August, with each responsible institution, in order to agree on the content of the passport of indicators that will embody the strategic document and their targets during each year of its implementation. The draft passport of indicators contains 41 indicators, of which 15 belong to the state responsibility of the National Coordinator Against Corruption, and the rest are followed by other responsible institutions. The working process will continue to design and conceptualize the Action Plan, which will turn the objectives set in the strategy into concrete products. The institutional working group of the Ministry of Justice is closely assisted in this process by the Technical Assistance Project of the European Union Delegation.

#### Drafted Monitoring Report on the implementation of the Anticorruption Action Plan, January-June 2022

**24.08.2022:** The technical secretariat at the National Anti-Corruption Coordinator in the Ministry of Justice has drafted the monitoring report January - June 2022, of the current anti-corruption strategy, 2015-2023. This first draft of the monitoring report provides information on the progress of 18 specific objectives regarding the three approaches of prevention - punishment - awareness and also presents the 6-month evaluation of performance indicators, reflecting this way data of implementation of the measures and activities. In the first 6 months of 2022, it comes up that from the total of 56 measures and 103 activities foreseen for implementation, 37 measures and 65 activities have been fully implemented, 12 measures and 8 activities are in the process of implementation, and 7 measures and 30 activities remain unimplemented. The draft of the monitoring report has been sent for internal consultation with all the contributory institutions. This report will be discussed and approved at the meeting of the Anti-Corruption Coordinating Committee on the next round.

2020-2023

Through Integrity Plans, the Directorate of Programs and Projects in the field of Anticorruption has continued to work on the establishment and implementation of the instruments on the fight against corruption in the public administration. During August, the subordinate institutions of the Ministry of Justice have started the process of monitoring the implementation and drafting reports of the Integrity Plans. All these institutions have been technically assisted by the Ministry of Justice. The monitoring reports of their Integrity Plans will be completed and published within September 2022.

## The Anticorruption component plays an essential role in the "Screening" presentations in the European Union

In the framework of the Screening process, as a commitment of the Albanian Government in the framework of the European Union membership process, Albanian public institutions have engaged in a round of simulation presentations, in order to unify and improve their final format. This simulation exercise serves the presentations in the technical meetings that will take place in Brussels for chapter 23 and 24. The presentation of the anti-corruption component will be led by the Ministry of Justice in the role of the National Anti-Corruption Coordinator. This presentation contains a summary of the national and international legislative framework of the anti-corruption field, and the level of compliance in the national framework. The anti-corruption component also contains an overview of the monitoring of the Intersectoral Anti-Corruption Strategy 2015 – 2023, the drafting of the new strategy 2023 – 2030, a detailed description of the General Anti-Corruption Directorate and the Network of Anti-Corruption Coordinators, statistical data, updates related to the process of Integrity Plans as well as the self-assessment report within the 24 recommendations of GRECO V. In order to have a more comprehensive framework, the anti-corruption component also contains data from partner institutions in the fight against corruption, such as the Central Election Commission, the Police of the State, HIDAACI and AASCA. These data will help to fully frame the preventive approach in the fight against corruption.
